Area of Emphasis

Ms. Mosites represents clients in the Pennsylvania Commonwealth Court's original jurisdiction, challenging agency action that departs from the requirements of Pennsylvania's Regulatory Review Act and Administrative Law and Procedure.

Ms. Mosites has assisted clients responding to agency requests for information, notices of violation and orders issued under state and federal laws, including Pennsylvania's Oil and Gas Act, Clean Streams Law, and Solid Waste Management Act, as well as the Clean Air Act and the Clean Water Act.
