## **Area of Emphasis**

Varun Shekhar is a shareholder in Babst Calland's Environmental, Transportation Safety, and Intellectual Property groups. Mr. Shekhar's Environmental practice emphasizes federal, state and local regulatory matters arising under the Clean Air Act (CAA). He counsels facilities across the country regarding permitting, compliance determination and assurance, CAA Section 114 information requests, environmental audits, and emerging air quality issues including climate change and regulation of greenhouse gas emissions. Mr. Shekhar draws upon his science and engineering background to help clients develop compliance solutions that are practical, technically and legally sound, and to advise entities in the course of enforcement actions by the U.S. Environmental Protection Agency, U.S. Department of Justice, and state agencies, as well as citizen suits within federal district and appellate courts.

In addition to his experience involving the CAA, Mr. Shekhar frequently counsels clients in the areas of radiological safety, water quality permitting and enforcement under the Clean Water Act, health and safety, remediation, and environmental due diligence.

Mr. Shekhar's Transportation Safety practice emphasizes advising clients within a variety of industries on the Pipeline and Hazardous Materials Administration's (PHMSA's) hazardous materials regulations, as well as regulations administered by the Federal Railroad Administration (FRA) and the Federal Motor Carrier Safety Administration (FMCSA). In addition, he provides counseling regarding PHMSA's pipeline safety regulations for natural gas, hazardous liquid, and carbon dioxide pipeline systems.

Mr. Shekhar's Intellectual Property practice emphasizes providing counseling on trademark matters under the Lanham Act. He regularly assists clients with obtaining registrations before the US Patent and Trademark Office (USPTO), advising clients on potential infringement issues, and representing clients in proceedings before the USPTO's Trademark Trial and Appeal Board (TTAB).
