After serving two tours in Iraq, he was selected to serve as an instructor/writer at the Army Medical Command's headquarters in San Antonio, TX, where he taught essential lifesaving skills to entry-level combat medics and leadership skills to senior noncommissioned officers, developed curriculum, and provided management and oversight to the Department's 315 individual programs of instruction. Mr. Etheredge is a member of both the Sergeant Morales and Sergeant Audie Murphy Clubs, for which he served as chapter president and senior advisor.

Throughout his military career, Mr. Etheredge developed a passion for education and started taking college courses whenever he could. In 2015, he left the Army and enrolled full time to finish his undergraduate coursework at the University of the Incarnate Word, from which he graduated *cum laude*. During college, Mr. Etheredge worked full time as a musician, owned and operated a recording studio, and served as a staffer for a member of the Texas House of Representatives. As a musician, he released several albums, played in some of the biggest music festivals in the world, and went on multiple tours, including a two-week stint in Japan.

In 2017, Mr. Etheredge enrolled in the Washington and Lee University School of Law, from which he graduated *cum laude* in 2020.
